

TOWN OF WESTON
INSTRUCTIONS FOR PAYMENT OF
2022 PROPERTY TAXES



Enclosed please find your property tax statement for 2022.
Please note the following:

- **Incredible Bank (Weston and Rothchild locations) will be accepting TOWN tax payments until Jan 31st. They will not take Dog License payments; these need to be mailed to the Town.**
- **The preferred methods for payment are by check or money order through the mail or dropping in the Town drop box using the enclosed return envelope or payment at Incredible Bank (Weston and Rothchild).**
- **Credit Card payments will NOT be accepted.**
- **In-person tax payments can be made by appointment at the Town Office, 5209 Mesker Street.**
- **See tax statement for further payment information.**

Property tax payments being made for a 2022 income tax deduction will need to be postmarked by December 31, 2022. Postmark will be sufficient for date of payment. Full payment or first installment payments are due in the Town of Weston office by January 31, 2023. Receipts for all payments will be mailed to the property owner. Overpayments from escrow checks will be refunded by mail to the property owner with a Town issued check. **ALL second** installments will be collected beginning February 1st, 2023, at the **Marathon County Treasurer's** office. **Second** installments are due no later than July 31, 2023.

Lottery Credit Reminder: If you were occupying your **primary** residence as of **January 1, 2022**, you are entitled to a Lottery Credit on your 2022 tax bill. Please look for it on your tax bill. If it has been omitted, please notify the Town of Weston for an adjustment. If you moved into your residence during 2022 you are **not** entitled to a Lottery Credit until your December 2023 tax bill.

DOG OWNERS

State law and local ordinance requires that all dogs must be licensed by the time they become five (5) months of age. Dog licensing and renewals will also be managed through the Town of Weston and can be done through the mail along with your property tax payment if you wish. Tags will be mailed to you with a receipt for payment. Please fill out the form below to obtain a dog license. *Incomplete forms cannot be processed!* If you have more than one dog, please copy the form or enclose the necessary information on another sheet of paper. Licenses are current for the year issued.

NOTICE—2023 DOG LICENSE FEES

NOTICE TO DOG OWNERS & KEEPERS OF DOGS—PLEASE COMPLETE THIS FORM. Return either in person or with payments by mail. State law requires that all dogs must be licensed by the time they become five (5) months of age. Before a license can be issued, **YOU MUST FURNISH A RABIES VACCINATION CERTIFICATE** to show proof of vaccination against rabies which is also required by State Statutes. Fines of \$155.50 may be imposed for failure to have your dog vaccinated.
